Part II additional information: During 2007 BPN's founder and chairman advanced \$3,000,000 to BPN for the publication of the "Blue Planet Run" book for worldwide public education about the safe water crisis and other working capital needs. The loans were due on demand and carried a 5% interest rate through the end of 2008. During 2009 the loans were retroactively adjusted to be interest free, resulting in a \$277,814 positive restatement of net assets as of December 31, 2009. Additional advances of working capital of \$48,806, \$104,917 and \$199,102 during 2010, 2009 and 2008, respectively, have resulted in a total outstanding balance due of \$3,352,825 as of August 16, 2013. The entire loan balance went to zero on August 16, 2013 after a combination of \$2,352,825 loan forgiveness and \$1,000,000 donation.
